Local Information

Visiting Mankato in the fall is a treat. The leaves start to change throughout the Minnesota River Valley providing scenic byways and beautiful hiking throughout the area. The Red Jacket and Socata trails are easily accessible, and the Rasmussen Woods trail runs through a wildlife preserve in the heart of Mankato. Minneopa State Park, 5 miles west of Mankato on U.S. Highway 169, boasts beautiful waterfalls and a hiking trail ranging from 1-5 miles. Visitors can also stop at the Seppmann Mill, a wind driven gristmill fashioned in the German style from native stone and lumber or hike throughout the park and its camping grounds.


MSU itself has great cultural opportunities, including a cutting-edge art gallery and nationally recognized theater. In town, visitors can take advantage of the Blue Earth County Historical Society Museum, the Treaty Site History Center, and the River Hills Mall for shopping. The Old Downtown area of Mankato features fun shops, including several antique stores as well as a Wine Café, which has live music every weekend. Old Downtown is also the home of the Coffee Hag, a fair trade, and all organic coffee house with fresh vegetarian meals. The owner and chef will both be participating in the conference, and participants will get to sample homemade scones and fair trade coffee at the conference. The Savoy is also a local favorite, featuring delicious Mediterranean food. Most of the pubs in the downtown area also host a wide variety of live music including bluegrass, jazz, rock, and country and are no more than 10 minutes from campus.

In addition to the local Mankato opportunities, there are also a wide-range of small towns between 20 and 45 minutes away that maintain their own sense of community and charm. For example, New Ulm, MN is a German settlement which houses both Schell's Brewery, the oldest and largest family run brewery in the United States and the Morgan Creek Vineyards. Both the Brewery and the Vineyards offer tours and private tastings by appointment. The Winery also hosts the Cambria Crush Grape Stomp and participants receive a free case of wine.

The local committee is committed to the idea of community throughout the conference and will provide light breakfast and coffee, lunch, afternoon snack, and dinner each day. Other options are readily available at the CSU, or within a 5-minute walk to the University Square Village which offers Chipotle, LeeAnn Chin's, Noodles and Co., Jimmy Johns, Inta Juice,

and Jonny B's Sports Bar. Mankato also offers a variety of food choices including Mexican, Italian, Mediterranean, Chinese, Vietnamese, as well as all the major chains at a variety of prices.
